

Directions for Fiscal Appeals

Complete appeals will be reviewed by a panel comprised of several University offices. Each appeal will be examined for extenuating circumstances.

Types of appeals that can be submitted:

- Excess Credit Hours: The resident student has exceeded the [excess hours limit](#) and is being charged out-of-state tuition.
- Tuition and fee refund: The student has fully withdrawn past the first day of class due to extenuating and unavoidable circumstances and is requesting a tuition refund.
 - This does NOT apply to Q-dropped classes

Rules:

- For tuition refunds, the Panel will only review semesters within **one year** of the current semester.
- All decisions made by the Panel are **final** and not subject to further appeal to any other office.

Typical circumstances the panel has reviewed:

- Hospitalization of the student
- Death or major illness of an **immediate** family member (parents, siblings, children)
- Chronic medical conditions that cause poor performance or frequent absence
- Circumstances that are unforeseen and urgent in nature, severely affecting the student's ability to participate in courses.

Circumstances not accepted by the panel:

- Change of major
- Not knowing or understanding university rules, regulations, or state law
- Poor performance in difficult classes
- Taking on optional responsibilities (jobs, internships, extra courses, etc.)

How to complete the appeal:

- **Complete this form after reading all requirements and limitations.**
- Write a detailed, but concise narrative (page 2) that answers these questions as applicable-
 - What led you to this situation?
 - Who was involved?
 - Why were you not able to continue the semester (if withdrawn)?
 - What caused you to need more than the 30 extra hours allowed by the State of Texas to complete your degree (for Excess Credit Hour appeals only)?
 - Include a timeline if possible.
- Official documentation that supports the reasons presented in your narrative - **REQUIRED**
 - A doctor's note for medical reasons
 - A counselor or therapist's note for mental health reasons
 - A letter from a University official supporting your narrative

Do **not** include:

- Essays of character such as "I have always wanted to be an Aggie...etc."
- Original documents. **Paperwork will not be returned.**
- Images - all explanations should be thorough enough to avoid the need for photos.
